## **Ambassador Massinga's Comment on US and Ethiopia Policy:**

**Human Rights Focus:** Ambassador Massinga emphasized the importance of human rights in U.S.-Ethiopia relations. He highlighted the need for accountability and justice for all ethnic groups affected by the ongoing conflicts.

**Call for Dialogue:** He called for inclusive dialogue among all Ethiopian stakeholders to foster peace and unity. Ambassador Massinga stressed the significance of
